

Call to Order

Ruth Hamilton, Church Council Chair, called the meeting to order at 11:34 am. A quorum was present.

Opening Prayer

Pastor Michelle de Beauchamp led off the meeting with an opening prayer.

Minutes of 115th Annual Meeting, February 5, 2023

Minutes from the 115th Annual Meeting, held on February 5, 2023, were reviewed. Sue Varland made a motion to approve the minutes as written. LouJean O'Brien and Sharal Patton second the motion. The motion was approved unanimously. The minutes are included in Annual Meeting Report.

Council President's Letter

Ruth Hamilton read her letter to the congregation. The letter is included in the Annual Meeting Report. Her letter states that we are blessed, seeing God at work through our challenges and triumphs. We are a beacon of hope to the community. Through joys and sorrows we have become closer as a church family, as we exemplify God's love. Our "Sabbatical -in-place" while Pastor Michelle was away on her sabbatical will reap benefits for years to come. It is a joy to see our growth and we look to continue to be blessed and grateful in the coming year.

Senior Pastor's Letter

Pastor Michelle discussed her letter to the congregation. The letter is included in the Annual Meeting Report. Her letter addresses several topics: acts of service, outreach, education, and worship. She spoke to a sabbatical "Heart Pilgrimage" workshop she will offer on April 27. She thanks the congregation and Lily Foundation for her unforgettable sabbatical experience.

Congregational Records for 2023

Pastor Michelle summarized the congregational records for 2023. Total Sunday worship attendance, including in-person and online worshipers, was 125. We received two new members by transfer, had three marriages, four baptisms, two confirmations, and two burials.

Elections 2024

Pastor Michelle announced that there are three new vacancies on the Church Council, as Joyce Easton, Linda Borth, and Sharal Whitecliff-Patton are leaving Council. Randall Daugherty and Patti Barker have agreed to be considered for two positions. Mike Erkkinen and Teri Moody have agreed to be considered for re-election. Phil Olafsen made a motion to approve Randall, Patti, Mike, and Teri for these positions. Callie White seconded the motion. The motion was approved unanimously.

Treasurer's Report 2023 and Budget for 2024

Tony Enzler, Council Treasurer, announced that we are in a very good financial position. Thank you to the congregation. There is a concern that written pledges have dropped significantly. Grants and other opportunities are out there for additional funding. A question was asked as to what is the most critical financial issue. Tony responded that facilities issues are most critical at this time. As we peel back on problems that arise, more things get uncovered. Pastor Michelle said that we are in better financial shape than many, even larger, congregations. Linda Borth said we need to give Pastor Michelle and Teri Julian a round of applause for keeping office expenses down. A motion was made and seconded to approve the Treasurer's Report and 2024 Budget. The motion was approved unanimously. The Treasurer's Report is included in the Annual Meeting Report.

Endowment Report for 2023

Tony Enzler addressed the Endowment Report for the Endowment Committee. The Committee has decided to move the interest monies forward. The question was asked if we are in a financial hole right now. Tony responded that is not the case. While we are slightly in the red, our assets more than cover that. LouJean O'Brien asked if we need another capital campaign. Pastor Michelle said we will get back to that later in the meeting. Linda Borth asked about getting the bells working. Pastor Michelle said that she and Randall Daugherty agree we need a new system. Randall added that the current system uses Windows 95. The Endowment Report is included in the Annual Meeting Report.

Memorial Fund Report for 2023

Ruth Hamilton discussed the Memorial Fund. It currently has a balance of \$3,752.55. The Memorial Fund Report is included in the Annual Meeting Report.

Martha Circle Fund Report for 2023

Becky Root discussed the Martha Circle Treasurer's Report 2023. The report is included in the Annual Meeting Report. Last year the flea market and plant sale did very well. Sharal Patton has indicated that there will be another plant sale in June (June 1). Total donations to the Martha Circle fund in 2023 were \$3,874.46. The breakdown of those figures is shown in the report. Barbara Fairchild made a motion to approve the Endowment, Memorial Fund, and Martha Circle Reports for 2023. Sharal Patton seconded the motion. The motion passed unanimously.

Property Maintenance Committee Report for 2023

Pastor Michelle discussed the Property Maintenance Committee Report. The report is included in the Annual Meeting Report. She asked for people to submit ideas for landscaping along M Street. We will include some stepping stones in the project. Regarding the west wall project, copies of the engineering report are available. The plan is to put a steel beam on each side of the stained glass window. Ray Kahler has been working with Alan Gozart with Harbor Architects. We don't have a quote right now for the project. The Hoquiam Historic Commission has agreed that we can install metal siding as we did for the steeple. John Larson said that when they were able to see the siding on the steeple, they were ok with installing it on the west wall as well. Sue Varland asked about removing the stained glass. Ray said we have not obtained a quote on that, but the range is likely between \$20,000 and \$40,000. Pastor

Michelle said that the stained glass people said some minor re-leading may be needed. Barbara Fairchild commented that we are so blessed to have people work with us on this, including the contractors and John Larson. Pam Hunter asked how dangerous are conditions with the wall. She wouldn't be surprised if the entire wall through the sacristy may need to be repaired or replaced. Pastor Michelle said the project would need another capital campaign. She is also looking into possible loans. JoAnn Ray asked if we would need to send the stained glass window to Seattle for repairs. Ray responded that it is likely that any part of the window that does not need repair could stay here. JoAnn said that nine years ago, James documented the condition of the windows, so that we would have an indication of their value. A motion was made and seconded to approve the Building Maintenance Committee Report. The motion passed unanimously.

Music & Worship Report for 2023

The Music and Worship Report is included in the Annual Meeting Report. Thanks to Kari Hasbrouck and Troy George for all their efforts.

Outreach, Education, and Youth Report for 2023:

Pastor Michelle summarized the Outreach, Education, and Youth Report included in the Annual Meeting Report. Linda Borth announced that there will be two fundraisers, one on March 17 and another in May.

Adjourn with Prayer

The meeting adjourned at 12:13 pm with a closing prayer from Pastor Michelle, followed by a motion to adjourn by Phil Olafson. The motion was seconded, and approved unanimously.

Council President's Letter 2024

February 23, 2025

Dear Church Family -

Have you been amazed this year at what God has done? What a year it has been!

We started 2024 with our pastor refreshed and restored from her sabbatical adventures. Our congregation enjoyed its own "sabbatical in place," learning and growing in new ways during her absence.

Earlier in the year we viewed the West wall and window restoration as our greatest challenge. Through the combination of generous donors and several successful fundraisers, the money needed to accomplish these repairs was met. Additionally, we were able to fund a new carillon bell system. Though the process has taken longer than expected, we have seen God's perfect timing at work. As you all know, the steeple was struck by lightning in November, exploding the top half of the structure, knocking out the electrical system and causing other damage. Fortunately, the stained-glass window and carillon bells had not yet been installed and escaped damage. The original church structure has now been completely rewired and updated from 1950's era work. Insurance will cover most of the repair costs, supplemented by a GoFundMe account and other donations. Again and again, God has provided.

Outreach into our community continues and grows. The Rose Center is serving more and more people, through Al-anon, Girl Scouts, Spiritual Direction counseling, Harbor Food Pantry, the Community Garden, fundraisers, youth events and other uses. Our teams provide Monthly Community Meals and Union Gospel Mission meals while the church hosts several groups including Homemakers, VASA and Sons of Norway. Supporting the Hoquiam Food and Clothing Bank and providing hygiene supplies for the homeless are ongoing ministries.

We have worshipped together, prayed together, mourned together and rejoiced together, caring for one another and reaching out to care for others. We have grown in numbers and in faith. We continue to be a beacon of hope in Grays Harbor and beyond. And we have been blessed!!

Our church is healthy and faithful, with you, its members, expressing in so many ways a willingness to serve. Thank you for your hard work and generous hearts! May God continue to bless each of you beyond what you deserve or expect.

Endowment Report 2024

The Endowment Fund of Saron was established by action of a congregational meeting on January 28, 2007. The purpose of the fund is to support the work and mission of Saron-1st in and beyond our community. No portion of the fund is to be used to support regular operating expenses.

Endowment Fund contributions from Saron members and others are invested with the Mission Investment Fund and Thrivent Mutual Funds A relatively small amount of money, not intended to generate investment income, is held in a checking account at Timberland Bank. This account provides an efficient way to disperse funds to worthy projects.

In accordance with guidelines in Chapter 20 of the Saron Lutheran – 1st Presbyterian Church Constitution, the Endowment Committee has the option to distribute annual gains from the Mission Investment Fun and Thrivent Financial. The Constitution allows for distributions ranging from none to all gains in a given year. Per by-laws, annual distribution of endowment proceeds is to be allocated as follows: 30% for Mission Outreach (ELCA); 30% Capital improvements; 10% Community Outreach; 10% Youth; and 20% (committee discretion).

Building Maintenance/Property Team Report

With both the "West-wall-window" project, and the lightning-damage repairs.... 2024 felt like a year "on hold".

The custodial "mop room" project: When the lightning hit; the electricians "took over" this space for all their work in that vicinity of the building— so that project stalled-out. They are out of there now; we can re-start that project.

Members of our Committee did as-needed, emergency repair work on the elevator- (whenever it broke down)- learning a lot about it. However, with talk of a new elevator project, that work is now completely out of our hands.

We also did some work up in the "cry room", in preparation for the new "bells" installation- (thanks, Mike Erkkinen). With extensive lightning-strike window/ water-damage; this entire project is also now out of our hands.

After much planning and discussion, this Spring, we were also going to begin work out on the "M" Street landscaping project, but the future need to get big, heavy, equipment back into that area- (to make high steeple repairs)- we decided to hold off on any landscaping work until all the overhead construction/repair is completed.

However, we were able to complete some projects through the year:

Heavy-cleaning, scraping, and painting were completed in the "Martha-Circle" small closet behind the kitchen area. That's where our nice, big tablecloths are presently stored. It was in really bad shape- damp and musty. It looks much better for now. (A new, much better, storage-location for our beautiful tablecloths is planned!).

Shelving-work was recently completed in the "Quilter's Room". During my work there, <u>several</u> Church members told me that we need to "go thru all the "stuff" that has accumulated over the years and determine what the Church actually <u>needs</u> for its activities and functions". Building/re-building shelving for general storage in every cubby-hole here and there just to meet <u>additional</u> storage "needs(?)" is expensive. I personally agree with all those who'd like to see a reorganization of the <u>entire</u> storage issue throughout the building, for efficiency and safer, easier, access. Our huge Saron building has a relatively small amount of organized, centralized, dedicated, <u>storage space</u>. Compounding the problem, damage from the lightning strike has taken away much-needed storage space up in the "cry room"; we can't use that space until the steeple/window/water-damage work is complete.

Again, this last year, there was an exceptional amount of time and effort put forth by those who regularly take care of "their areas" of landscaping, shrubbery, and

the Rose Garden, along both 8th Street and M Street. Much pruning this year was needed. In addition, quite a bit of spraying and weed burning was needed. These jobs take a lot of time and effort. They are just "quiet", on-going, under-the-radar, and almost "taken for granted". They are a huge part of what keeps the <u>outside</u> of our Church and property looking sharp. You know who you are--- many thanks!

Throughout the year, there were also plenty of small maintenance tasks completed, as they turned up.

So, with the new year upon us, and some of the lightning-repairs done (for now), we have a full list of projects that we can resume work on, including: Finishing-up work on the custodial mop-room; repairing/repainting both sets of the big, mainentry doors- (8 huge doors in all); improving the access and storage of the 2 huge ladders we use regularly for Church maintenance-issues/decorations/etc.; actually determining what the Church needs to keep stored here— and work on storage for that; and, lastly, the re-organization of the maintenance-furnace-room.

Separately, I'd also like to mention that Knut Totland has taken on the project of repairing and re-doing the small bathroom up near the Communion-room. A small room--- but a big job! Big thanks for that!

That's all I have for now. Your Building Maintenance Committee will keep pluggin' along in doing our best to keep things working as best we can. Please fill out a handy "work request" in the big book or contact any one of us— any time-- if there are any needed repairs, and/or with your suggestions and ideas!

This long-time ministry is still going strong with our 4 teams of 24 volunteers making meals for 60 people every 3rd Monday of the month.

Boots for Bears

We have been overwhelmed by the generosity of our small community. Grays Harbor has truly heard our call to provide appropriate footwear, sweats, socks, and underwear for the students of Emerson, Central and Lincoln Elementary Schools.

To date, we have received 35 check donations and numerous cash contributions of \$8070.00 for 2024. With these funds, we set up a room at Emerson Elementary, stocking it with shoes, boots, and clothing for a total of \$3290.40. The staff have been incredibly responsive, and we're pleased to report that every child in need of clothing or footwear has received the items they require. The end of year balance for this account was \$4756.60.

We then expanded our efforts to the other two elementary schools in Hoquiam – Central and Lincoln. We made significant deliveries to both schools on November 11^{th} and December 12^{th} . All three schools are now in contact with us whenever a need arises for specific sizes or items. We also encourage staff to inform us if additional clothing items are needed.
